



INVITATION TO BID FOR THE SUPPLY AND DELIVERY OF 7,000 BAGS CERTIFIED INBRED RICE SEEDS FOR THE RICE SEED SUBSIDY PROGRAM FOR REGISTERED REGISTRY SYSTEM FOR BASIC SECTORS IN AGRICULTURE (RSBSA) FARMERS IN THE CITY OF ALAMINOS, PANGASINAN

1. The **CITY GOVERNMENT OF ALAMINOS, PANGASINAN** through the *Special Purpose Appropriation* intends to apply the sum of *Five Million Three Hundred Twenty Thousand Pesos Only (Php 5,320,000.00)* being the Approved Budget for the Contract (ABC) to payments under the contract for the **SUPPLY AND DELIVERY OF 7,000 BAGS CERTIFIED INBRED RICE SEEDS FOR THE RICE SEED SUBSIDY PROGRAM FOR REGISTERED REGISTRY SYSTEM FOR BASIC SECTORS IN AGRICULTURE (RSBSA) FARMERS IN THE CITY OF ALAMINOS, PANGASINAN**. Bids received in excess of the ABC shall be automatically rejected at bid opening.

		Guidelines and Specifications:
		1. At least 85% seed germination taken not more than two (2) months prior to delivery and must pass BPI-NSQCS standard;
		2. Must be harvest of January 2022 onwards prior to delivery;
		3. Must be stored in storage facility at the time of post-qualification until delivery;
		4. Packed at 20kg/bag with certification tag from BPI-NSQCS; and
		5. Prescribed packaging must be spray painted/printed out with Alaminos City logo labelled with NOT FOR SALE in red color.

2. The **CITY GOVERNMENT OF ALAMINOS, PANGASINAN** now invites bids for the above Procurement Project. Delivery of the Goods is required within **Thirty (30) Calendar Days upon receipt of the Notice to Proceed**. Bidders should have completed within **two (2) years** from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary *“pass/fail”* criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
 - a. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the law or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.
4. Prospective Bidders may obtain further information from the **CITY GOVERNMENT OF ALAMINOS, PANGASINAN** and inspect the Bidding Documents at the address given below during **8:00AM to 5:00PM**.
5. A complete set of Bidding Documents may be acquired by interested Bidders on **March 15 – April 4, 2022** from the given address and website below and upon payment of a non-refundable fee for the Bidding Documents in the amount of **Ten Thousand Pesos Only (Php 10,000.00)** at the BAC Secretariat, City Engineering Office, City of Alaminos, Pangasinan.

Bidding Documents may also be downloaded from the website of the Philippine Government Electronic Procurement System (PhilGEPs) provided that bidder shall pay the fee for the Bidding Documents prior to the submission of bids.
6. The **CITY GOVERNMENT OF ALAMINOS, PANGASINAN** will hold a Pre-Bid Conference on **March 23, 2022, 10:00 A.M. at the City Budget Office, City Hall Building, City of Alaminos, Pangasinan**.
7. Bids must be duly received by the BAC Secretariat on or before **April 4, 2022, 9:30 A.M.** at the **City Budget Office, City Hall Building, City of Alaminos, Pangasinan**. Late bids shall not be accepted.
8. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB Clause 14**.
9. Bid opening shall be on **April 4, 2022, 10:00 A.M.** at the **City Budget Office, City Hall Building, City of Alaminos, Pangasinan**. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
10. The **CITY GOVERNMENT OF ALAMINOS, PANGASINAN** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 35.6 and 41 of the 2016 Revised Implementing Rules and Regulations (IRR) of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
