



**INVITATION TO BID FOR THE PROPOSED ASPHALT PAVEMENT AT NARRA STREET FARM TO MARKET ROAD (FMR), BRGY. BOLANEY, CITY OF ALAMINOS, PANGASINAN**

1. The **CITY GOVERNMENT OF ALAMINOS, PANGASINAN** through the *Special Purpose Appropriation 2022* intends to apply the sum of **Two Million Three Hundred Seventy-Eight Thousand Seven Hundred Sixty-Three Pesos and 01/100 Only (Php 2,378,763.01)** being the Approved Budget for the Contract (ABC) to payments under the contract for the **PROPOSED ASPHALT PAVEMENT AT NARRA STREET FARM TO MARKET ROAD (FMR), BRGY. BOLANEY, CITY OF ALAMINOS, PANGASINAN**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The **CITY GOVERNMENT OF ALAMINOS, PANGASINAN** now invites bids for the above Procurement Project. Completion of the Works is required **Eleven (11) Calendar Days**. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
4. Interested bidders may obtain further information from the **CITY GOVERNMENT OF ALAMINOS, PANGASINAN** and inspect the Bidding Documents at the address given below from **8:00AM to 5:00PM**.
5. A complete set of Bidding Documents may be acquired by interested bidders on **February 22 – March 14, 2022** from given address and upon payment of a non-refundable fee for the Bidding Documents in the amount of **Five Thousand Pesos Only (Php 5,000.00)** at the BAC Secretariat, **City Engineering Office, City of Alaminos, Pangasinan**.  
  
Bidding Documents may also be downloaded from the website of the Philippine Government Electronic Procurement System (PhilGEPS) provided that bidders shall pay the fee for the Bidding Documents prior to the submission of bids.
6. The **CITY GOVERNMENT OF ALAMINOS, PANGASINAN** will hold a Pre-Bid Conference on **March 2, 2022, 10:00 A.M. at the City Budget Office, City Hall Building, City of Alaminos, Pangasinan**.
7. Bids must be received by the BAC Secretariat on or before **March 14, 2022, 9:30 A.M.** at the **City Budget Office, City Hall Building, City of Alaminos, Pangasinan**. Late bids shall not be accepted.
8. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 15.
9. Bid opening shall be on **March 14, 2022, 10:00 A.M.** at the **City Budget Office, City Hall Building, City of Alaminos, Pangasinan**. Bids will be opened in the presence of the bidders’ representatives who choose to attend the activity.
