**EXECUTIVE ORDER NO. 09**

**"CHANGING THE COMPOSITION OF THE LOCAL PROJECT OFFICE CREATED UNDER EXECUTIVE ORDER NO. 05, SERIES OF 2002 DATED FEBRUARY 28, 2002"**

**WHEREAS**, on February 28, 2002, E.O. No. 05 was issued creating the Local Project Office (LPO) that will be responsible in the implementation of Rural Infrastructure Development Component of the Department of Agrarian Reform-Asian Development Bank-Agrarian Reform Communities Project (DAR-ADB-ARCP);

**WHEREAS**, several executive orders were subsequently issued changing the composition of the LPO with the corresponding change in the administration of the City of Alaminos, Pangasinan;

**WHEREAS**, the latest issuance regarding the composition of the LPO was E.O. No. 10, Series of 2010, dated September 15, 2010;

**WHEREAS**, with the change of administration, there is a need to correspondingly change the composition of the LPOs as provided by DAR-ADB-ARCP and E.O. No. 10, Series of 2010 dated September 15, 2010;

**WHEREAS**, the Local Government Unit of the City of Alaminos, Province of Pangasinan is a recipient of a Pitong Gatang-Bayanihan Agrarian Reform Communities project from DAR-ADB-ARCP;

**WHEREAS**, under the Memorandum of Agreement, it is mandatory for the City Local Government Unit to create a Local Project Office;
