

**CREATION OF THE PUBLIC FINANCE MANAGEMENT (PFM) TEAM OF THE  
CITY OF ALAMINOS, PANGASINAN**

**WHEREAS**, it is the commitment of every Local Government Unit to pursue with the highest degree of effectiveness and efficiency the sustainable delivery of public goods and services to its constituents;

**WHEREAS**, it is the City's foremost aim to further intensify good governance anchored on participatory, transparent and accountable leadership through strengthening of public institution by continued improvement of its Local Public Finance Management System (PFM);

**WHEREAS**, the issuance of the Public Financial Management Tool for the Local Government Unit (PFMAT for LGUs) is a significant mechanism by which the local government could measure the local PFM system and determine which areas need improvement;

**WHEREAS**, to undertake a local assessment, a special body needs to be established for the purpose;

**NOW THEREFORE**, I ARTHUR F. CELESTE, by virtue of the powers vested in me as the City Mayor of the City of Alaminos here orders:

**Section 2. Functions of the Public Financial Management Team – The PFM Team shall perform the following:**

1. Be in charge with the establishment of a baseline information on the state of the Local Public Financial Management System;
2. Conduct Local Assessment using the framework provided by the Public Financial Management Tool for Local Government Units (PFMAT for LGUs);
3. Formulate recommendations towards the improvement of the Local PMS; and
4. Perform other functions as maybe required.

**Section 3. Effectivity**

This Executive Order shall take effect immediately.
