**REORGANIZING/RECONSTITUTING THE CITY FISHERIES AND AQUATIC RESOURCES  
MANAGEMENT COUNCIL OF THE CITY OF ALAMINOS, PANGASINAN**

WHEREAS, Section 69, Article II of Republic Act No. 8550, otherwise known as the Philippine Fisheries Code of 1998 provides for the creation of Fisheries and Aquatic Resources Management Councils (FARMCs) both on the national and local levels that shall act as advisory body in the protection, sustainable development and management of fishery and aquatic resources;

WHEREAS, DILG Memorandum Circular Nos.99-142 and 2010-131, support the creation of the FARMCs as well as encourage local government units to incorporate in their local development plans and budget, programs and projects related fisheries and aquatic resource management;

WHEREAS, the FARMC is by law a body that would empower the fisherfolk to be an active partner of the government in protecting our fisheries and aquatic resources and consequently eradicate poverty among marginal folks:

NOW, THEREFORE, I, ARTHUR F. CELESTE, City Mayor of the City of Alaminos, Pangasinan, by virtue of the powers vested in me by law, do hereby reorganize/reconstitute the City Fisheries and Aquatic Resources Management Council (CFARMC) of the City of Alaminos as follows:

Section 1. Composition.

Section 2. Functions.

The City FARMC shall exercise the following functions:


- A. Assist in the preparation of the City Fishery Development Plan and submit such plan to the City Development Councils;

- B. Recommend the enactment of city fishery ordinances to the sangguniang panlungsod through its Committee on Fisheries;
- C. Assist in the enforcement of fishery laws, rules and regulations in city waters;
- D. Advise the sangguniang panlungsod on fishery matters through its Committee on Fisheries, if such has been organized; and
- E. Perform such other functions which may be assigned by the sangguniang panlungsod.

Section 3. Effectivity.

This Executive Order shall take effect immediately.
