REORGANIZATION/RECONSTITUTING THE CITY ANTI-DRUG ABUSE COUNCIL  
OF THE CITY OF ALAMINOS, PANGASINAN

WHEREAS, the 1987 Philippine Constitution mandates that the government shall promote the quality of life of the people;

WHEREAS, Section 16 of the Local Government Code provides that local government units shall pursue undertakings to improve public morals and maintain peace and order, among other equally significant concerns;

WHEREAS, the increasing use of illegal drugs has significantly contributed to the incidence of heinous crimes;

WHEREAS, the problem on illegal drugs has to be addressed much more effectively to help ensure community peace and harmony;

WHEREAS, DILG Memorandum Circulars 98-227 and 99-236, enjoin local government units to create their Local Anti-Drug Abuse Councils;

NOW, THEREFORE, I, ARTHUR F. CELESTE, City Mayor of the City of Alaminos, Pangasinan, by virtue of the powers vested in me by law, do hereby reorganize/reconstitute the City Anti-Drug Abuse Council of the City Alaminos, Pangasinan as follows:

Section 2. Rules and Responsibilities.


The roles and responsibilities of the Council shall be the following:

- A. Serve as a focal point through which various organizations and individuals work together cooperatively in the planning, implementation and evaluation of programs on the drug abuse prevention.
- B. Provide for an effective mechanism for the cooperation of existing services and programs and those which might be developed in the immediate future.
- C. Provide for a mechanism to obtain funds, volunteers, facilities and technical expertise; and
- D. Perform other related responsibilities as may be assigned by competent authorities.

Section 3. Effectivity.

This Executive Order shall take effect immediately.
