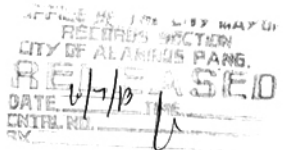

EXECUTIVE ORDER NO. 042
Series of 2013

REORGANIZING/RECONSTITUTING THE CITY COUNCIL FOR THE PROTECTION OF CHILDREN OF THE CITY OF ALAMINOS, PANGASINAN

WHEREAS, DILG Memorandum Circular No. 2002-121 dated August 5, 2002 provides for the organization and strengthening of the Local Councils for the Protection of Children (LCPC), which will serve as an advisory body of the local government units towards the promotion, development and protection of children.

NOW, THEREFORE, I ARTHUR F. CELESTE, City Mayor of the City of Alaminos, Pangasinan, by virtue of the powers vested in me by law, do hereby reorganize/reconstitute the City Council for the Protection of Children (CCPC) of the City of Alaminos with the following:

Section 1. Composition.

The City Council for the Protection of Children shall be composed of the following members:

Section 2: **Functions.**

The functions of the Council are the following:

- A. Formulate plans, programs and policies for children that are gender-fair, culturally relevant and responsive to the needs of diverse groups of children from 0 to below 18 years ago;
- B. Prepare AWWP or children and recommend appropriations to the Sanggunian;
- C. Provide coordinative linkages with other agencies and institutions in the planning, monitoring and evaluation of plans for children;
- D. Provide technical assistance and recommend financial support to the Barangay Council for the Protection of Children;
- E. Establish and maintain database on children in the city; —
- F. Foster education of every child;
- G. Advocate for the establishment and maintenance of playgrounds, day care centers and other facilities necessary for child and youth development;
- H. Recommend local legislations promoting child survival, protection, participation and development, especially on the quality of television shows, media prints and coverage, which maybe detrimental to children, and with appropriate funding support;
- I. Assist children in need of special protection and refer cases filed against child abusers to proper agencies/institutions;
- J. Conduct capability building programs to enhance knowledge and skills in handling children's program;
- K. Document barangays best practices on children;
- L. Monitor and evaluate the implementation of the program and submit quarterly status report to PCPC;
- M. Perform such other functions as provided for in the ECCD and other child related laws.

Section 3. Secretariat.

The City Social Welfare and Development Office, headed by the City Social Welfare and Development Officer shall be designated as the secretariat to be CCPC.


Section 4. Funding.

Upon recommendation of this council, the City Government of Alaminos shall provide funding for programs/projects/activities on children and ensure that these are implemented.

Section 5. Effectivity.

This Executive Order shall take effect immediately.
