EXECUTIVE ORDER NO. 046
Series of 2013

“RECONSTITUTING THE LOCAL POVERTY REDUCTION ACTION TEAM OF THE CITY OF ALAMINOS, PANGASINAN”

WHEREAS, Republic Act No. 7160 or the Local Government Code of 1991 provides local government units greater responsibility to improve the quality of life of people in the communities and ensure the general welfare of its constituencies;

WHEREAS, DBM-DILG-DSWD-NAPC Joint Memorandum Circular NO. 4 Series of 2013 entitled, **POLICY GUIDELINES AND PROCEDURES IN THE IMPLEMENTATION OF THE GRASSROOTS PARTICIPATORY BUDGETING PROCESS (FORMERLY CALLED BOTTOM-UP BUDGETING) FOR THE FY 2015 BUDGET PREPARATION**”, provides for the reconstitution of the Local Poverty Reduction Action Team (LPRAT) to spearhead the formulation and monitoring of the Local Poverty Reduction Action Plan (LPRAP);

WHEREAS, the war against poverty, which is a priority of national and local administration, requires the participation of various sectors in government, civil society organizations, and business;

NOW THEREFORE, I, ARTHUR F. CELESTE, City Mayor of the City of Alaminos, Pangasinan, by virtue of the powers vested in me by law, do hereby order the following:

Section 1. *Reconstitution and Composition.*

The Local Poverty Reduction Action Team (LPRAT) of Alaminos City shall be reconstituted and shall be composed of the following, namely:

Section 2. Roles and Responsibilities.


The LPRAT shall:

- a) Organize and facilitate the conduct of a Local Poverty Reduction Action Planning workshop for the formulation of the LPRAP and the identification of priority poverty reduction projects;
- b) Agree on a list of priority poverty reduction projects for 2015 based on the LPRAP and submit it to the RPRAT using the template provided in Annex B; and
- c) Conduct quarterly meetings to monitor the status of the approval and integrating the priority poverty reduction projects into the budgets of participating agencies and monitor the implementation and status of the projects.

Section 3. Effectivity.

This Executive Order shall take effect immediately.
