**REORGANIZING/RECONSTITUTING THE CITY PRICE COORDINATING COUNCIL
OF THE CITY OF ALAMINOS, PANGASINAN**

WHEREAS, Republic Act No. 7581 as further amplified by DILG Memorandum Circular No. 2004-75 dated June 21, 2004, provides for the creation and activation of the Local Price Coordinating Council to monitor, convene and formulate policies and strategies to keep prices of basic consumer goods at reasonable levels;

NOW, THEREFORE, I, ARTHUR F. CELESTE, City Mayor of the City of Alaminos, Pangasinan, by virtue of the powers vested in me by law, do hereby order the reorganization/reconstitution of the City Price Coordinating Council of the City of Alaminos, Pangasinan as follows:

Section 1. Composition.

The City Price Coordinating Council of the City of Alaminos shall be composed of the following:

Section 2. Duties and Functions.


The City Price Coordinating Council shall perform the following duties and functions:

- A. Coordinate and rationalize the programs to stabilize prices and supply of member agencies in the City;
- B. Recommend to the (National Price Coordinating Council) or to the Implementing Agencies suggested retail prices (SRP) and/or the price ceilings for certain basic necessities and prime commodities in their respective areas;
- C. To conduct in-depth analysis on causes for price fluctuations;
- D. To recommend action steps to correct unwarranted price increases and supply shortages.

Section 3. Effectivity.

This Executive Order shall take effect immediately.
