**“DESIGNATING THE FOCAL PERSON/S FOR THE GRASSROOTS PARTICIPATORY BUDGETTING AND PLANNING (GPBP) IMPLEMENTATION IN THE CITY OF ALAMINOS”**

**WHEREAS**, Executive Order No 43, S 43 dated 13, May 2011 mandated the Cabinet to organize into Clusters – the Good Governance and Anti-Corruption Cluster, the Human Development and Poverty Reduction Cluster, that are tasked to improve the overall quality of life of the Filipino, translating the gains on Good Governance; and the Economic Development Cluster, to oversee implementation of the Bottom-up Budgeting (BUB);

**WHEREAS**, Bottom-up Budgeting, now termed as the Grassroots Participatory Budgeting and Planning (GPBP) is an approach to preparing the budget proposal of agencies taking into consideration the development needs of poor cities/municipalities as identified in their respective Local Poverty Reduction Action Plans (LPRAP) that shall be formulated with strong participation of basic sector groups and other civic organization;

**WHEREAS**, the Department of Social Welfare and Development (DSWD) is the host agency in the implementation of Four Social Protection projects namely; (1.) Construction of Day Care Center, (2.) Sustainable Livelihood Programs (SLP), (3.) Auxiliary Services for Persons with Disabilities (PWD), (4.) Social Pension to Indigent Senior Citizens;

**WHEREAS**, one of the required documents prior fund release from host agency is the need to Appoint/Designate GPBP Focal Person/s,

**WHEREAS**, the Focal Persons shall ensure the smooth flow of project implementation,


**NOW THEREFORE**, I, **ARTHUR F. CELESTE**, City Mayor of the City of Alaminos, Pangasinan, by virtue of the powers vested in me by law, do hereby designate the following CSWDO Staff to be the LGU Focal Persons of the GPBP projects implementation; to wit:

- A. Construction of Day Care Center.....Mrs. Elizabeth A. Radoc
- B. Sustainable Livelihood Program.....Mrs. Lilane T. Etrata and Mrs. Leilani F. Bolivar
- C. Auxiliary Services to Persons with Disabilities.....Ms. Trisha C. Tandoc
- D. Social Pension to Indigent Senior Citizens.....Mrs. Jane R. Fontelera
