"CREATING THE GENDER AND DEVELOPMENT (GAD) MONITORING AND EVALUATION (M&E) TEAM OF THE CITY OF ALAMINOS, PANGASINAN"

WHEREAS, Philippine Commission on Women, Department of the Interior and Local Government, Department of Budget and Management, and National Economic and Development Authority Joint Memorandum Circular No. 2013 - 01 entitled, "Guidelines on the Localization of the Magna Carta of Women" provides for the creation of the GAD Monitoring and Evaluation Team;

Section 1. CREATION AND COMPOSITION OF THE GAD M&E TEAM

Section 2. FUNCTIONS

The GAD M&E Team shall:

a. Evaluate the outcomes of the LGU GAD policies, programs and projects; and

b. Submit a GAD Evaluation Report to the DILG Regional Office at the end of the Local Chief Executive's three - year term.

Section 3. EFFECTIVITY

This executive order shall take effect immediately.
