"CREATING THE GENDER AND DEVELOPMENT (GAD) MONITORING AND EVALUATION (M&E) TEAM OF THE CITY OF ALAMINOS, PANGASINAN"

WHEREAS, Philippine Commission on Women, Department of the Interior and Local Government, Department of Budget and Management, and National Economic and Development Authority Joint Memorandum Circular No. 2013 – 01 entitled, "Guidelines on the Localization of the Magna Carta of Women" provides for the creation of the GAD Monitoring and Evaluation Team;

WHEREAS, the creation of the GAD M&E Team would strengthen the M&E System for gender-responsive programs and projects;

WHEREAS, there is a need to create a GAD M&E Team to assess the progress of GAD – related programs, projects and activities;

NOW THEREFORE, I, ARTHUR F. CELESTE, City Mayor of the City of Alaminos, Pangasinan, by virtue of the powers vested in me by law, do hereby order:

Section 1. CREATION AND COMPOSITION OF THE GAD M&E TEAM
