CREATING THE COMPOSITE INSPECTION TEAM FOR THE IMPLEMENTING RULES AND REGULATIONS OF ORDINANCE NO. 2013-10

WHEREAS, Ordinance No. 2013-10 entitled "The Alaminos City, Pangasinan Tourism Code of 2013" was enacted by the Sangguniang Panlungsod on November 11, 2013;

WHEREAS, to effectively implement Ordinance No. 2013-10, Implementing Rules and Regulations (IRR) WAS promulgated through Executive Order No. 02 Series of 2014.

NOW THEREFORE, I, ARTHUR F. CELESTE, City Mayor, Alaminos City, by virtue of the powers vested in me by the law, do hereby order:

Section 1. Creation. There shall be a created Composite Inspection Team for the Implementing Rules and Regulations of Ordinance No. 2013-10.

Section 2. Composition. The Inspection Team shall be composed of the following:

Section 3. Functions. The Composite Inspection Team shall have access to the registry books or card of the tourism establishments, all parts and facilities thereof, and the right to interview any employee and investigate any fact, condition, or matter which may be necessary to determine any violation or aid in arriving at a just and correct conclusion. As such, the team shall perform the following duties and functions:

1. Conducts regular inspections for the purpose of verifying compliance with the requirements of the Code and other existing laws, checklist will be provided by the Alaminos City Tourism Office (ACTO);
2. Conducts inspection every six (6) months during office hours;
3. Conducts special inspection through the recommendation of the Alaminos City Tourism Office; and
4. Reports findings and recommendations to the Local Chief Executive five (5) days from the date of the conduct of inspection;

Section 4. Effectivity. This order shall take effect immediately and shall be in full force and effect unless sooner revoked in writing by the undersigned.
