ORDINANCE NO. 2006-04

ORDINANCE PROVIDING FOR TOURISM-ENVIRONMENTAL EDUCATION PROGRAM IN THE CITY OF ALAMINOS, PRESCRIBING MEASURES FOR ITS IMPLEMENTATION THEREOF, AND FOR OTHER PURPOSES.

WHEREAS, the City Government of Alaminos has been steadily succeeding in implementing its tourism and environmental programs after it regained from the national government the management, administration, and maintenance of the Hundred Islands National Park by virtue of Executive Order No. 436 issued by Her Excellency President Gloria Macapagal Arroyo on June 21, 2005;

WHEREAS, the City Government seeks to involve a greater number of its constituents, particularly the learners from all levels of educational institutions, in accelerating the accomplishment of its tourism and environmental thrusts in line with the Ten-Point Agenda for the City of Alaminos;

WHEREAS, the **Tourism-Environmental Education Program for the City of Alaminos** (hereinafter referred to as the **Program**), which is a strategic, systematic, and concerted information-education activities in all schools in the City, aims at promoting tourism in the City of Alaminos via the theme "Huwag Maging Dayuhan sa Sariling Bayan";

WHEREAS, the City Government is hoping that through the Program, the learners will raise the level of their consciousness on tourism, environment, traditions, culture, and history of the City, as well as develop in themselves a sense of concern, co-ownership, and active participation in the City's tourism and environmental programs by re-echoing to their families, relatives, and friends whatever they would learn as a result;

WHEREAS, with the present status of the City of Alaminos as the Education Center of Western Pangasinan, students coming from the nine municipalities of the First District enroll in various secondary and tertiary schools in the City, thereby increasing the extent of information dissemination and its consequent impact to the District and the whole Province as well;

WHEREAS, the Sangguniang Panlungsod believes that it is an integral part of its mandated duty to act on legislations that would help the City Government to effectively and successfully achieve the pursuit of its tourism and environmental thrusts.

NOW, THEREFORE, be it enacted by the Sangguniang Panlungsod in session assembled, that:

SECTION 1. TITLE. This Ordinance shall be known as **Tourism-Environmental Education Program for the City of Alaminos.**

SECTION 2. SCOPE. This Ordinance shall cover all levels of public and private schools, barangay organizations and assemblies, business organizations, civic, non-governmental and people's organizations, and all the other sectors in the City of Alaminos.

SECTION 3. IMPLEMENTING AGENCY. The City Tourism Office and City Information Office shall be the lead agencies in the implementation of this Ordinance, and shall likewise provide speakers, lecturers, or resource persons vis-à-vis the City's information and education campaign on tourism and environment.

SECTION 4. PRODUCTION OF INSTRUCTIONAL RESOURCES. The City Tourism Office and the City Information Office shall work hand-in-hand in the production of educational modules and audio-visual presentations containing the policies, goals, projects, developments, projects, ordinances, rules and regulations on the integrated tourism and environmental programs of the City of Alaminos.

SECTION 5. TIME ALLOTMENT DURING CLASS HOURS. School Heads/Administrators of public and private schools at all levels in the City of Alaminos are hereby encouraged:

- (1) To allot a minimum of thirty (30) minutes of their class hours, particularly during the time of Values Education, or Sibika in elementary, Araling Panlipunan in high school, and Current Social Issues in college for a once a week information-education lecture or audio-visual presentation on tourism and environment in the City of Alaminos; or,
- (2) To arrange for a school-wide symposium, panel discussion, or any appropriate medium on tourism and environment.

SECTION 6. TRAINING FOR TEACHERS. The City Government shall provide the necessary training for teachers, as significant partners in the City's information-education campaign on tourism and environment, in the use of educational modules and audio-visual presentations, jointly produced by the City Tourism Office and City Information Office, for their classes.

SECTION 7. FUNDING. The funding for the implementation of this ordinance shall come from the appropriation of both the City Tourism Office and City Information Office.


SECTION 8. SEPARABILITY. If for any reason, any provision, section, or part of this ordinance is declared not valid by a Court of competent jurisdiction, suspended, or revoked by the Sangguniang Panlalawigan, such judgment shall not affect or impair the remaining provisions, sections, or parts thereof, which shall remain or continue to be in full force and effect.


SECTION 9. EFFECTIVITY. This Ordinance shall take effect upon approval.


