ORDINANCE NO. 2008-03-A

WHEREAS, the most awaited common clamor by most local residents to convert the town of Alaminos, Pangasinan into component city have finally come into reality upon enactment of Republic Act No. 9025 last 08 February 2001, ratified during the plebiscite held on 28 March 2001;

WHEREAS, since the time of its conversion into city, Alaminos City has now become progressive commercial, educational, agricultural, economic and tourist district which continuously generates substantial revenues for its various programs and projects due to the collective efforts and satisfactory performances shared by its dedicated officials and employees;

WHEREAS, such gesture of revealing concern and mutual support for the attainment of a common development goal deserves to give emphasis and due recognition;

NOW, THEREFORE:

BE IT ORDAINED BY THIS AUGUST BODY IN SESSION ASSEMBLED, THAT:

SECTION 1. This ordinance shall be known as:

"AN ORDINANCE GRANTING ANNUAL CITYHOOD ANNIVERSARY BONUS TO ALL APPOINTED AND ELECTED OFFICIALS, AND PERMANENT AND CASUAL EMPLOYEES OF THE CITY GOVERNMENT OF ALAMINOS, PROVINCE OF PANGASINAN, BEGINNING THIS YEAR 2008 AND EVERY YEAR THEREAFTER, IN THE AMOUNT OF THREE THOUSAND PESOS (P3,000.00) EACH, TO BE GIVEN ON OR BEFORE THE ANNIVERSARY DATE ON MARCH 28TH.

SECTION 2. BENEFICIARIES AND AMOUNT TO BE GRANTED - All active/incumbent appointed and elected officials, and permanent and casual employees of the City Government of Alaminos, Province of Pangasinan who have continuously rendered One Hundred Twenty (120) days on or before the anniversary dates of each year, March 28th, are entitled to an annual cityhood anniversary bonus of P3,000.00 each; and for those new ones who have not yet completed the required One Hundred Twenty (120) days will be given a consideration of certain percentage amount at the desired amount by the Local Chief Executive;

SECTION 3. SCHEDULE OF THE RELEASE OF THIS SPECIFIC INCENTIVE - The release of this anniversary bonus shall be made on or before March 28th of each year beginning this year 2008;
