ORDINANCE NO. 2008-09

IMPOSING IMPOUNDING FEE FOR MOTORIZED AND NON-MOTORIZED BANCAS FOUND OPERATING ILLEGALLY WITHIN THE TERRITORIAL WATERS OF ALAMINOS CITY, PROVIDING PENALTIES FOR VIOLATION THEREOF AND FOR OTHER PURPOSES.

EXPLANATORY NOTE

WHEREAS, records show that almost every month if not everyday the City's Bantay Dagat/POSO and other law enforcement personnel apprehend registered/unregistered Motorized Banca and Non-Motorized/Water Crafts operating illegally within the city waters of Alaminos;

WHEREAS, some Motorboats/Water Crafts registered are being used to conduct illegal activity prejudicial to the interest of the City Government;

WHEREAS, it is the policy of the City Government to protect the interest of legitimate boat owners/operators under City's operation Pantay-Pantay Program;

NOW, THEREFORE, be it ordained by the City Council in session assembled, That:

SECTION I. TITLE - This ordinance shall be known as an "Ordinance Imposing Impounding fee for all apprehended Motorized and Non-Motorized Bancas/Water Crafts in the City of Alaminos"

SECTION II. PENALTY - Impounding Fee

There shall be imposed the following fees:

a. for municipal motorized and non-motorized boat/bancas (3 gross tons below)

1. *first three (3) days* - P250.00
2. *succeeding days* - P50.00/day

b. for commercial fishing vessel

1. fishing boat
 - First three (3) days* - P500.00
 - Succeeding days* - P100.00/day
2. fishing gear
 - First three (3) days* - P100.00
 - Succeeding days* - P50/day

SECTION III. The City Agricultural Officer or his authorized representative shall issue impounding receipt to the owner of the vessel/gear upon proper issuance of confiscation receipt.

SECTION IV. Impounded fishing boats and gears shall only be released upon payment of corresponding fine and impoundment fee to the City Treasurer of Alaminos City.

SECTION V. Any ordinance, rules and regulations Contrary to the provision of this ordinance is hereby amended, repealed or modified accordingly.

SECTION VI. **Effectivity** - This Ordinance shall take effect in accordance with the provision of R.A. 7160 (Local Government Code of 1991).
