ORDINANCE NO. 2014-09

ORDINANCE NAMING THE CHILDREN'S PARK AND ACTIVITY CENTER ESTABLISHED AT THE FORMER LOCATION OF THE CITY MOTOR POOL AT SABARO STREET, POBLACION, THIS CITY AS "ALAMINOS CITY CHILDREN'S PARK AND ACTIVITY CENTER"

WHEREAS, RULE VIII, Article 43 of the IRR of Republic Act 7160, otherwise known as the Local Government Code of 1991, provides, "An LGU may, through an ordinance, permanently or temporarily close or open any road, alley, park or square within its jurisdiction";

WHEREAS, to provide additional recreational facility and activity center in the city for residents and tourist alike, this august body enacted City Ordinance No. 2014-08 opening/establishing a children's park and activity center at the former location of the city Motor Pool;

WHEREAS, to provide identity to the children's park and activity center there is a need to properly name it;

WHEREFORE, premises considered and on motion of Councilor Fatima Ann S. Isla duly seconded by Councilor Rany S. de Leon and Liga ng mga Barangay President Salvador C. Camba

Be it ordained by the Sangguniang Panlungsod of the City of Alaminos, in session duly assembled to name the children's park and activity center at the former location of the City Motor Pool at Sabaro Street, Poblacion, this city as "ALAMINOS CITY CHILDREN'S PARK AND ACTIVITY CENTER"




