ORDINANCE NO. 2015-01

ORDINANCE PROVIDING FOR THE TEMPORARY CLOSURE OF PORTION OF C.P. GARCIA STREET (BETWEEN ALAMINOS CITY HALL BUILDING AND PLAZA MARCELO OCHAVE) FROM FEBRUARY 25, 2015 TO MARCH 31, 2015 FOR TIANGGE STALLS AND 2ND WESTERN PANGASINAN AGRI AND TOURISM EXPO 2015; PORTION OF QUINTOS STREET (NORTH SIDE OF PLAZA MARCELO OCHAVE) FROM FEBRUARY 25, 2015 TO MARCH 31, 2015 FOR THE FOOD STALLS; PORTION OF QUEZON AVENUE, (INFRONT OF NEPO MALL, ALAMINOS) AND PORTION OF MARCOS AVENUE, (INFRONT OF GENERIC PHARMACY), FROM 3:00 O'CLOCK IN THE AFTERNOON OF MARCH 20, 2015 TO MARCH 22, 2015, FOR STREET DANCING AND STREET PARTY; PORTION OF QUEZON AVENUE (INFRONT OF THE CITY HALL BUILDING/CORNER OF C.P. GARCIA STREET UP TO FRONT SIDE OF MC DONALDS STORE) FROM 9:00 O'CLOCK IN THE MORNING TO 6:00 O'CLOCK IN THE AFTERNOON OF MARCH 28, 2015 FOR THE MOTORCYCLE ROAD SHOW; AND BRAGANZA BOULEVARD (BY-PASS ROAD) FROM 5:00 O'CLOCK IN THE MORNING TO 7:00 O'CLOCK IN THE AFTERNOON OF MARCH 29, 2015 FOR THE MOTOR EXHIBITION ACTIVITY IN LINE WITH THE CELEBRATION OF THE 2015 PATRONAL AND CITY FIESTA.

EXPLANATORY NOTE

WHEREAS, it has been a tradition during the celebration of City Fiesta that Tiangge and Food Stalls are being established as one of the many attractions commemorating the celebration;

WHEREAS, various activities were scheduled to make the celebration more festive and bring out the artistic talents of youths in the locality like Street Dancing and Street Party;

WHEREAS, a Motorcycle Road Show and Motor Exhibition will also be one of the highlights of the celebration;

WHEREAS, due to several activities in line with the celebration of the forthcoming 2015 Patronal and City Fiesta, there is a need to temporarily close certain portion of city streets and Braganza Boulevard (By-Pass Road) to serve as venue for the scheduled activities on certain dates;

NOW THEREFORE, on motion of Councilor Margielou Orange D. Humilde, co-sponsored by Councilor Joseph T. Bacay duly seconded by Councilor Rufina J. Gabriel, it was

BE IT ENACTED by the Sangguniang Panlungsod in session duly assembled to:


SECTION 1. Temporarily close portion of C.P. Garcia Street (Between Alaminos City Hall Building and Plaza Marcelo Ochave) from February 25, 2015 to March 31, 2015 for Tiangge Stalls and 2nd Western Pangasinan Agri and Tourism Expo 2015; portion of Quintos Street (North Side of Plaza Marcelo Ochave) from February 25, 2015 to March 31, 2015 for the Food Stalls; portion of Quezon Avenue, (Infront of Nepo Mall, Alaminos) and portion of Marcos Avenue, (Infront of Generic Pharmacy), from 3:00 o'clock in the afternoon of March 20, 2015 to March 22, 2015, for Street Dancing and Street Party; portion of Quezon Avenue (Infront of the City Hall Building/Corner of C.P. Garcia Street up to Front Side of Mc Donalds Store) from 9:00 o'clock in the morning to 6:00 o'clock in the afternoon of March 28, 2015 for the Motorcycle Road Show; and Braganza Boulevard (By-Pass Road) from 5:00 o'clock in the morning to 7:00 o'clock in the afternoon of March 29, 2015 for the Motor Exhibition Activity in line with the celebration of the 2015 Patronal and City Fiesta.


SECTION 2. This ordinance shall take effect upon approval.


