ORDINANCE PROVIDING FOR THE TEMPORARY CLOSURE OF PORTION OF G. MONTEMAYOR STREET (FROM THE CORNER OF QUEZON AVENUE UP TO PERIMETER FENCE OF THE DLSA BESIDE THE BFP STATION, INVOLVING A DISTANCE OF ABOUT 64.50 METERS) AND J. BRAGANZA STREET (TWO METERS FROM THE PERIMETER FENCE OF THE DLSA, INVOLVING A DISTANCE OF ABOUT 64.50 METERS) FOR THE CONVERSION (CONSTRUCTION) OF DON LEOPOLDO SISON AUDITORIUM TO DON LEOPOLDO SISON CONVENTION CENTER FROM APRIL 15, 2015 UP TO THE COMPLETION OF THE PROJECT

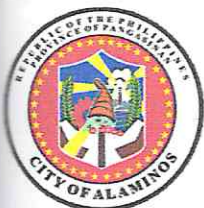
EXPLANATORY NOTE

WHEREAS, pursuant to City Ordinance No. 2014-19, series of 2014, this august body identified the conversion of the Don Leopoldo Sison Auditorium to Don Leopoldo Sison Convention Center as one of the priority projects to be financed from the LGU loan from the Land Bank of the Philippines;

WHEREAS, this project is now for implementation after going through the required process of implementing government projects under existing laws and regulations;

WHEREAS, since the implementation of this project requires the tearing down of the existing structure, there is a need to temporarily close a portion of G. Montemayor Street and J. Braganza Street to prevent any untoward incident which may risk the life and limbs of people and motor vehicles passing by the area;

NOW THEREFORE, on motion of Councilor Fatima Ann S. Isla duly seconded by Councilor Rufina J. Gabriel, it was

BE IT ENACTED by the Sangguniang Panlungsod in session duly assembled to:

SECTION 1. Temporary close portion of G. Montemayor Street (from the corner of Quezon Avenue up to the perimeter fence of the DLSA beside the BFP Station, with a distance of about 64.50 meters) and J. Braganza Street (two meters from the perimeter fence of the DLSA, with a distance of about 64.50 meters) for the conversion (construction) of Don Leopoldo Sison Auditorium to Don Leopoldo Sison Convention Center from April 15, 2015 up to the completion of the project;

SECTION 2. This ordinance shall take effect upon approval.
