ORDINANCE NO. 2015-04

ORDINANCE PROVIDING FOR THE TEMPORARY CLOSURE OF PORTION OF QUEZON AVENUE (IN FRONT OF THE CITY HALL BUILDING) ON MAY 3, 2015 FROM 9:00 IN THE MORNING UP TO 4:00 O'CLOCK IN THE AFTERNOON TO SERVE AS VENUE FOR THE VIEWING OF THE LIVE COVERAGE OF THE PACQUIAO-MAYWEATHER FIGHT

EXPLANATORY NOTE

WHEREAS, Manny Pacquiao has continuously bring pride and honor to the Filipino people for being a professional boxer who conquered eight World Division Titles under the World Boxing Organization;

WHEREAS, Floyd Mayweather is also considered a great boxer having consistently maintained his record of zero loss in his boxing career;

WHEREAS, these two great boxers will be having their boxing fight dubbed as the "Fight of the Century" on May 3, 2015;

WHEREAS, to show support to the People's Champ, the LGU-Alaminos will be covering the event and will be aired live at the LED Screen in front of the City Hall Building;

NOW THEREFORE, on motion of Councilor Perlito V. Rabago duly seconded by Councilor Jose Antonio Miguel Y. Perez and Liga ng mga Barangay President Salvador C. Camba, it was


