### ORDINANCE NO. 2015-05

**ORDINANCE PROVIDING FOR THE TEMPORARY CLOSURE OF PORTION OF C.P. GARCIA STREET (FROM THE CORNER OF QUEZON AVENUE UP TO THE CORNER OF QUINTOS STREET) FROM 5:00 O’CLOCK IN THE AFTERNOON ON MAY 7, 2015 UP TO 5:00 O’CLOCK IN THE AFTERNOON OF MAY 8, 2015 FOR THE CONDUCT OF A DISTRICT WIDE JOB FAIR OF THE PUBLIC EMPLOYMENT SERVICE OFFICE, ALAMINOS CITY**

### EXPLANATORY NOTE

**WHEREAS**, one of the major thrust of the Local Government Unit of the City of Alaminos is to support programs intended to increase job opportunities in the locality;

**WHEREAS**, one of these programs is Job Fair which is intended to provide opportunities for jobseekers to scout possible employment and for employers to inform the public of their company’s need in terms of human resources;

**WHEREAS**, the Public Employment Service Office, Alaminos City in coordination with other agencies and the business sector will be conducting a district wide job fair on May 8, 2015;

**WHEREAS**, since the activity requires a bigger venue, there is a need to temporarily close portion of C. P. Garcia Street;

**NOW THEREFORE**, on motion of Councilor Perlito V. Rabago duly seconded by Councilor Jose Antonio Miguel Y. Perez and Councilor Joseph T. Bacay, it was

**BE IT ENACTED** by the Sangguniang Panlungsod in session duly assembled to:

**SECTION 1.** Temporary close portion of C. P. Garcia Street (from the corner of Quezon Avenue up to the corner of Quintos Street ) from 5:00 o’clock in the afternoon on May 7, 2015 up to 5:00 o’clock in the afternoon of May 8, 2015 for the conduct of a district wide job fair of the Public Employment Service Office, Alaminos City.

**SECTION 2.** This ordinance shall take effect upon approval.


