ORDINANCE NO. 2015-07

ORDINANCE APPROVING THE APPROPRIATION OF COUNTERPART FUND OF THE LOCAL GOVERNMENT UNIT – ALAMINOS CITY, PANGASINAN IN THE IMPLEMENTATION OF THE “NEGOKART” (KABUHAYAN NG PAMILYA AANGAT!) PROGRAM, A PROJECT UNDER THE DEPARTMENT OF LABOR AND EMPLOYMENT (DOLE) AMOUNTING TO TWO HUNDRED THOUSAND PESOS (PHP 200,000.00) TO BE CHARGED UNDER THE 2015 GENERAL FUND OF THE CITY

WHEREAS, the Department of Labor and Employment (DOLE) is the national agency mandated to promote gainful employment opportunities, develop human resources, protect workers, and promote their welfare, and maintain industrial peace;

WHEREAS, in compliance with this mandate the DOLE is implementing the “NegoKart” or Negosyo sa Kariton project aimed to provide decent livelihood for the marginal sectors specifically the ambulant vendors in the country;

WHEREAS, the Sangguniang Panlungsod of Alaminos City, Pangasinan thru Resolution No. 2015-61, dated July 14, 2015, authorized the Honorable City Mayor Arthur F. Celeste to enter into a Memorandum of Agreement with the Department of Labor and Employment regarding the implementation of the “NegoKart Project” in the City of Alaminos, Pangasinan;

WHEREAS, under the “NegoKart” project, the LGU-Alaminos City is required to appropriate counterpart fund amounting to Two Hundred Thousand Pesos (Php 200,000.00) for the labor component of the Project (Forty units @ Php 5,000.00 per unit);

WHEREAS, the Office of the City Budget Officer duly issued a certification as to the availability of the necessary fund which was duly appropriated in the 2015 City Annual Budget under the General Fund;

NOW, THEREFORE, on motion of Councilor Joseph T. Bacay, duly seconded by Councilor Jan Marianne R. Fontelera
