### ORDINANCE NO. 2016-02

**ORDINANCE AMENDING CITY ORDINANCE NO. 2015-12 ENTITLED "ORDINANCE CREATING SIXTY FIVE (65) NEW POSITIONS IN THE LOCAL GOVERNMENT UNIT OF ALAMINOS CITY, PANGASINAN", SPECIFICALLY THE POSITION TITLE OF ADMINISTRATIVE OFFICER IV, SALARY GRADE 22 UNDER THE OFFICE OF THE CITY MAYOR (MARKET) TO SUPERVISING ADMINISTRATIVE OFFICER, AND THE POSITION TITLE OF ADMINISTRATIVE OFFICER I, SALARY GRADE 11 UNDER THE OFFICE OF THE CITY SOCIAL WELFARE AND DEVELOPMENT TO ADMINISTRATIVE OFFICER II.**

**WHEREAS**, Article 63, Rule XXII of the Local Government Code of 1991 provides that every Local Government Unit shall design and implement its own organizational structure and staffing pattern taking into consideration its priority needs, service requirements and financial capabilities consistent with the principles on simplicity, efficiency, economy, effectiveness, dynamism and public accountability, subject to the minimum standards and guidelines as prescribed by the Civil Service Commission, the Sangguniang Panlungsod of the City of Alaminos, Pangasinan duly enacted City Ordinance No. 2015-12 on October 6, 2015;

**WHEREAS**, the funding for the created positions under the said ordinance was duly appropriated in the Appropriation Ordinance No. 2015-02 otherwise known as the 2016 Annual Budget of the City Government of Alaminos, Pangasinan;

**WHEREAS**, upon review of the 2016 Annual Budget of the City Government by the Sangguniang Panlalawigan, a recommendation was submitted by the Local Finance Committee of the Province that the position titles of **Administrative Officer I** under the Office of the City Social Welfare and Development be changed to **Administrative Officer II**; and the Position tile of **Administrative Officer IV** under the Office of the City Mayor (Market) be changed to **Supervising Administrative Officer** to conform with the Conversion of Positions Performing Staff/Non-Technical Functions as duly provided for in Budget Circular No. 200-3 dated March 6, 2004;

**NOW, THEREFORE**, upon due deliberation of the merits surrounding the issue and on motion of Councilor Cirilo B. Radoc, duly seconded by Councilor Alfred Felix E. de Castro and Councilor Rany S. de Leon;


**BE IT ORDAINED BY THE SANGGUNIANG, PANLUNGSOD IN THE SESSION ASSEMBLED**, that:

**SECTION I - TITLE:** This ordinance shall be known as: "ORDINANCE AMENDING CITY ORDINANCE NO. 2015-12 ENTITLED "ORDINANCE CREATING SIXTY FIVE (65) NEW POSITIONS IN THE LOCAL GOVERNMENT UNIT OF ALAMINOS CITY, PANGASINAN", SPECIFICALLY THE POSITION TITLE OF *ADMINISTRATIVE OFFICER IV, SALARY GRADE 22* UNDER THE OFFICE OF THE CITY MAYOR (MARKET) TO *SUPERVISING ADMINISTRATIVE OFFICER*, AND THE POSITION TITLE OF *ADMINISTRATIVE OFFICER I, SALARY GRADE 11* UNDER THE OFFICE OF THE CITY SOCIAL WELFARE AND DEVELOPMENT TO *ADMINISTRATIVE OFFICER II*.


