ORDINANCE NO. 2016-03

ORDINANCE CHANGING THE NAME OF THE DON LEOPOLDO SISON AUDITORIUM TO DON LEOPOLDO SISON CONVENTION CENTER

EXPLANATORY NOTE

WHEREAS, the Local Government Unit of Alaminos City, Pangasinan in its thrust to make the city one of the prime tourist destinations in Region I recently converted the Don Leopoldo Sison Auditorium into a fully furnished air-conditioned building which may be utilized for conferences, symposia and other public gatherings or meetings;

WHEREAS, to conform to the status and primary purpose for its conversion, the Local Government Unit of the City of Alaminos intends to rename the Don Leopoldo Sison Auditorium to Don Leopoldo Sison Convention Center;

WHEREAS, Article 22 (e) of the Implementing Rules and Regulations of Republic Act 7160, otherwise known as the Local Government Code of 1991 provides that the sanggunians of component cities and municipalities may, in consultation with the National Historical Institute now known as the National Historical Commission of the Philippines, change the name of any other public place or building owned by the city or municipality within their respective territorial jurisdictions;

WHEREAS, in response to the letter consulting the matter to the National Historical Commission of the Philippines, the Commission informed the body that the intention to change the name of the building is a question of function and not of historical significance, therefore, the issue is outside the scope of the mandate of the National Historical Commission of the Philippines;

WHEREFORE, premises considered, and on motion of Councilor Alfred Felix E. de Castro, duly seconded by Councilor Rufina J. Gabriel, Councilor Rany S. de Leon, Councilor Perlito V. Rabago, Councilor Froebel A. Ranoy and Liga ng mga Barangay President Salvador C. Camba;
