**"ORDINANCE PROVIDING FOR THE TEMPORARY PARTIAL CLOSURE OF THE RIGHT SIDE PORTION OF C.P. GARCIA STREET BETWEEN LEGISLATIVE BUILDING AND SAINT JOSEPH CATHEDRAL, FROM CATHEDRAL GATE TO PASSENGER JEEPNEY PARKING AREA, FROM NOVEMBER 23, 2016 TO JANUARY 09, 2017, FOR BAZAAR/TIANGGE (DRY GOODS STALLS) AND THE LEFT SIDE PORTION FROM LEGISLATIVE BUILDING ENTRANCE TO THE INTERSECTION OF MONTEMAYOR STREET, FROM DECEMBER 21, 2016 TO JANUARY 01, 2017, FOR FIRECRACKERS AND PYROTECHNIC DEVICES STALLS; THE LEFT SIDE PORTION OF MONTEMAYOR STREET BESIDE PLAZA AGAPITO BRAGANZA, FROM THE INTERSECTION OF C.P.
