ORDINANCE NO. 2017-01

ORDINANCE IMPOSING FEES AND CHARGES FOR THE USE OF THE DON LEOPOLDO SISON CONVENTION CENTER AND FIXING THE RATES THEREOF AND FOR OTHER PURPOSES

EXPLANATORY NOTE

WHEREAS, the Local Government Unit of Alaminos City, Pangasinan in its thrust to make the city one of the prime tourist destinations in Region I recently converted the Don Leopoldo Sison Auditorium into a fully furnished air-conditioned building which may be utilized for conferences, symposia and other public gatherings or meetings;

WHEREAS, Article 129 of Republic Act 7160, otherwise known as the Local Government Code of 1991 in relation to Article 10, Section 5 of the 1987 Philippine Constitution provides, "Each local government unit shall exercise its power to create its own sources of revenue and levy taxes, fees, and charges subject to the provisions herein, consistent with the basic policy of local autonomy. Such taxes, fees, and charges shall accrue exclusively to the local governments."

WHEREAS, Article Five, Section 153 and Section 154 of Republic Act 7160 further provides that the local government units may impose and collect reasonable fees and charges for services rendered and may fix the rates for the operation of public utilities owned, operated and maintained by them;

WHEREAS, the City Government-Alaminos City intends to create additional source of income by renting out the Don Leopoldo Sison Convention Center and its facilities;

WHEREAS, a Public Hearing for the said proposal was conducted on July 26, 2016 which yielded positive response from the attendees;

BE IT ENACTED as it is hereby **ENACTED** by the Sangguniang Panlungsod of the City of Alaminos, Pangasinan in session duly assembled that:

SECTION I. Title of the Ordinance - This ordinance shall be known as an "Ordinance imposing fees and charges for the use of the Don Leopoldo Sison Convention Center and fixing the rates thereof and for other purposes";

**SECTION III. The following term used under this Ordinance shall mean:
Alaminos-based:**

- a. Those who are born in Alaminos City
- b. Those who are registered voters of Alaminos City
- c. Those accredited CSOs/NGAs/NGOs based in Alaminos City

SECTION IV. Separability Clause - If any provision of this ordinance or the application of such provision to any person or circumstance is declared invalid, the remainder of this ordinance shall not be affected.

SECTION V. Repealing Clause - All ordinances, resolutions and other issuances or parts thereof inconsistent herewith, are deemed repealed or modified accordingly.

SECTION VI. Effectivity - This ordinance shall take effect upon approval.
