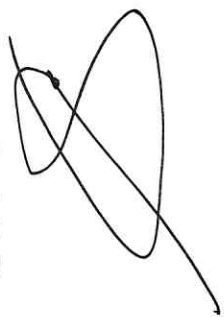

ORDINANCE PROVIDING FOR THE TEMPORARY FULL CLOSURE OF PORTION OF C.P. GARCIA STREET BETWEEN ALAMINOS CITY HALL BUILDING AND PLAZA MARCELO OCHAVE (FROM THE INTERSECTION OF QUEZON AVENUE TO CORNER OF QUINTOS STREET) FROM MARCH 06, 2017 TO MARCH 31, 2017, EXCLUSIVELY FOR PARKING AND OTHER AGRI-TRADE FAIR ACTIVITIES; TEMPORARY FULL CLOSURE OF PORTION OF QUEZON AVENUE (FROM THE INTERSECTION OF C.P. GARCIA STREET TO CORNER OF VERECIANO STREET, INFRONT OF ALAMINOS CITY HALL TO NEPO MART ALAMINOS) FROM 1:00 O’CLOCK IN THE AFTERNOON TO 8:00 O’CLOCK IN THE EVENING OF MARCH 23, 2017; TEMPORARY FULL CLOSURE OF THE LEFT SIDE PORTION OF QUINTOS STREET NORTH SIDE OF PLAZA MARCELO OCHAVE (FROM THE INTERSECTION OF C.P. GARCIA STREET TO CORNER OF SAN JOSE DRIVE) FROM MARCH 01, 2017 TO MARCH 31, 2017, FOR FOOD STALLS; AND TEMPORARY PARTIAL CLOSURE OF BOTH SIDES OF PORTION OF DIMASALANG STREET (FROM THE INTERSECTION OF QUEZON AVENUE TO BUREAU OF FIRE PROTECTION OFFICE) FROM 4:00 O’CLOCK IN THE AFTERNOON OF MARCH 17, 2017 TO 5:00 O’CLOCK IN THE MORNING OF MARCH 28, 2017, FOR PARKING

GARCIA STREET TO CORNER OF SAN JOSE DRIVE) FROM MARCH 01, 2017 TO MARCH 31, 2017, FOR FOOD STALLS; AND TEMPORARY PARTIAL CLOSURE OF BOTH SIDES OF PORTION OF DIMASALANG STREET (FROM THE INTERSECTION OF QUEZON AVENUE TO BUREAU OF FIRE PROTECTION OFFICE) FROM 4:00 O'CLOCK IN THE AFTERNOON OF MARCH 17, 2017 TO 5:00 O'CLOCK IN THE MORNING OF MARCH 28, 2017 TO SERVE AS PARKING AREA.
