**RESOLUTION AUTHORIZING THE CITY MAYOR, HON. ARTHUR F. CELESTE, TO NEGOTIATE, ENTER INTO MEMORANDUM OF AGREEMENT (MOA) WITH THE DEPARTMENT OF THE INTERIOR AND LOCAL GOVERNMENT (DILG) REPRESENTED BY DR. JULIE DAQUIOAG, CESO IV, ASST. REGIONAL DIRECTOR/OFFICER-IN-CHARGE, DILG REGION I AND DISBURSE THE PERFORMANCE CHALLENGE FUND FOR THE IMPLEMENTATION OF THE PROPOSED CONCRETING OF PALALI-PANDAYAN ROADS TO BE FUNDED UNDER THE 2013 PERFORMANCE CHALLENGE FUND (PCF) SUBSIDY IN THE AMOUNT OF THREE MILLION PESOS (₱3,000,000.00)**

**WHEREAS**, the President's vision as espoused in the Philippine Development Plan (PDP) 2011-2016 is to achieve inclusive growth-rapid and sustained environment that creates jobs and continuously reduces mass poverty. It also puts premium on the promotion of effective and honest governance particularly at the local level through intensive campaign on full disclosure of LGU operations, implementation of systems to determine performance of LGU's in terms of their state of local governance and compliance with policies, and institution of performance-based LGU incentives or awards;

**WHEREAS**, in 2011 and 2012, the Department of Interior and Local Government (DILG) through its Performance Challenge Fund (PCF) provided financial incentives to local government units that were commited in valuing the fundamentals of good governance by meeting the requirements of the Seal of Good Housekeeping (SGH), and in some cases, garnering the Gawad Pamana ng Lahi award;

**WHEREAS**, for 2013 the DILG through its PCF is instituting a progressive incentive system to influence LGU's to deliver public services more efficiently and create a business-friendly and safe environment.

**WHEREAS**, pursuant to DILG Directive issued by Dr. Julie Daquioag, CESO IV, Asst. Regional Director/Officer-in-Charge, DILG Region I, dated 19 December 2013, the Local Government Unit of Alaminos City, Pangasinan is among the few LGUs who passed the Seal of Good Housekeeping (SGH), thus entitled to access the 2013 Performance Challenge Fund (PCF) subsidy in the amount of Three Million Pesos (₱3,000,000.00);




