RESOLUTION AUTHORIZING AN AMOUNT OF FOURTEEN MILLION SIX HUNDRED SEVENTEEN THOUSAND NINE HUNDRED NINE PESOS AND 10/100 (PHP 14,617,909.10) OUT OF THE SAVINGS FROM THE APPROPRIATIONS FOR PERSONAL SERVICES, MAINTENANCE AND OTHER OPERATING EXPENSES, PROPERTY, PLANT AND EQUIPMENT AND NON-OFFICE FOR THE CURRENT YEAR TO BE UTILIZED AS PRODUCTIVITY ENHANCEMENT INCENTIVE TO CITY GOVERNMENT EMPLOYEES FOR FISCAL YEAR 2013.

WHEREAS, the local government employees have continued to serve the public with zeal, dedication and efficiency despite economic difficulties;

WHEREAS, the local government employees should be amply rewarded for their laudable efforts in extending effective and efficient delivery of basic services to the constituents of this City;

WHEREAS, Administrative Order No. 276, dated December 15, 2009 authorized the grant of Productivity Enhancement Incentive (PEI) to government employees;

WHEREAS, the Department of Budget and Management issued Budget Circular no. 2013-3, dated November 21, 2013 providing for the guidelines on the advance payment of the Productivity Enhancement Incentive (PEI) to government employees for FY 2013;

WHEREAS, pursuant to paragraph 9.0 of Budget Circular 2013-3 and in the spirit of the yuletide season and finally, as a reward for the commendable services of the city government employees, this body deemed it proper to authorize the use of savings from the operation of the city government to grant the productivity enhancement incentive for FY 2013 to all qualified employees of the City of Alaminos, Pangasinan;
