ROXAS III FOR THE ISSUANCE OF ONE (1) UNIT PATROL JEEP EARMARKED FOR ISSUANCE FROM THE CY-2011 CAPABILITY ENHANCEMENT PROGRAM (CEP) TO THE ALAMINOS CITY POLICE STATION, ALAMINOS CITY, PANGASINAN

WHEREAS, former City Mayor Hernani A. Braganza thru a letter dated November 19, 2012, requested the Department of Interior and Local Government for the allocation of two (2) units of patrol vehicles for the use of the Alaminos City Police Station;

WHEREAS, in response to this request, Police Director, Arnulfo R. Perez, DPA, PESE, Director for Logistics, informed then City Mayor Braganza that the Alaminos City Police Station was earmarked for issuance of one (1) unit of Patrol Jeep to be issued as soon as it is made available;

WHEREAS, the said Patrol Jeep is not yet issued to the Alaminos City Police Station up to the present time;

WHEREAS, P/Supt. Domingo R. Soriano, Officer-in-Charge of the Alaminos City Police Station, requested this august body for intervention thru a Resolution requesting for the issuance of the Patrol Vehicle to increase mobility of the police personnel in the city;

NOW THEREFORE, upon due deliberation of the merits surrounding the request and on motion of Councilor Perlito V. Rabago, duly seconded by Councilor Joseph T. Bacay, it was


