RESOLUTION NO. 2014-104

RESOLUTION AUTHORIZING BANGKO PANGASINAN, ALAMINOS CITY BRANCH TO OFFER SERVICES IN ORDERING NSO/PSA DOCUMENTS TO BANK CLIENTS IN ALAMINOS CITY

WHEREAS, Bangko Pangasinan, a rural bank operating in the city, is currently revitalizing the traditional rural banking services by expanding its products and services;

WHEREAS, in line with this expansion, Bangko Pangasinan formed a partnership with Ruralnet, Inc. to provide the platform to deliver financial services to the countryside by enabling the community to have direct access to products and services normally available in the urban areas like Bayad Centers for payment of Telecom Bills, Credit cards bills, remittances and ordering of NSO/PSA documents;

WHEREAS, the LGU-Alaminos City is currently operating BREQS (Batch Request System) in ordering NSO/PSA documents;

WHEREAS, in order to operate a NSO/PSA ordering payment system in cases where the LGU is operating BREQS, a resolution from the Sanggunian concern granting permission to any establishment intending to offer such service is required;

WHEREAS, Gregory de Guzman, President and CEO of Bangko Pangasinan, in a letter dated July 23, 2014, submitted a request to this august body for a Sanggunian Resolution authorizing the bank to serve bank in clients in Alaminos City in ordering NSO/PSA documents;

WHEREAS, the LGU-Alaminos City intends to provide other option to the public in ordering of NSO/PSA documents and reaffirm its commitment to make the city business-friendly;

WHEREAS, to ensure that competition between the LGU and the Bank will not exist, the cost of this service offered by Bangko Pangasinan must not be equal nor lower to the cost of the same service offered to the public by the LGU-Alaminos City;




