DECLARING VALID AND OPERATIVE AS A WHOLE THE SUPPLEMENTAL BUDGET NO. 1-2014 OF BARANGAYS BUED, DULACAC, LANDOC, MAAWI, MACATIW, PALAMIS, POGO AND SABANGAN AND SUPPLEMENTAL BUDGET NO. 2-2014 OF BARANGAYS BALAYANG AND TAWIN-TAWIN, AS FAVORABLY ENDORSED BY THE LOCAL FINANCE COMMITTEE DATED AUGUST 20, 2014

WHEREAS, the Barangay Councils of Bued, Dulacac, Landoc, Maawi, Macatiw, Palamis, Pogo, Sabangan, Balayang and Tawin-Tawin, as favorably endorsed by the Local Finance Committee dated August 20, 2014, submitted for review and evaluation their Supplemental Budget No. 1-2014 and Supplemental Budget No. 2-2014, pursuant to Item (i) (a) ART. 99, RULE XVII, of the Rules and Regulations Implementing the Local Government Code of 1991;


