RESOLUTION NO. 2014-108

RESOLUTION REMANDING BARANGAY ORDINANCE NO. 02, SERIES OF 2014 OF BARANGAY SAN ROQUE, THIS CITY, ENTITLED: "AN ORDINANCE REGULATING THE OPERATION OF VIDEOKE WITHIN THE TERRITORIAL JURISDICTION OF BRGY. SAN ROQUE, ALAMINOS CITY, PANGASINAN" FOR BEING INCONSISTENT WITH LAW

WHEREAS, the Barangay Council of San Roque, submitted for review and evaluation their Brgy. Ordinance No. 02, series of 2014, pursuant to ART. 111, RULE XVII, of the Rules and Regulations Implementing Republic Act 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Laws and Rules Committee of this august body conducted initial review and evaluation on the documents submitted and found out that the subject of the said Brgy. Ordinance is not within the scope of the prescribed powers of the Sangguniang Barangay to regulate because it is lodged with the Sangguniang Panlungsod, pursuant to Section 458 (vii) of the same Act;

WHEREAS, after subsequent thorough review and evaluation on the subject ordinance, this body during its regular session finally found that the same should be returned for being inconsistent with law;

NOW THEREFORE, on motion of Councilor Fatima Ann S. Isla, duly seconded by Councilor Rufina J. Gabriel and Liga ng mga Barangay, President, Salvador C. Camba, it was

RESOLVED to remand, as it is hereby **REMANDED**, Brgy. Ordinance No. 02, series of 2014 of Brgy. San Roque, this city for being inconsistent with law or enacted beyond the scope of the prescribed powers of the Sangguniang Barangay.

RESOLVED FURTHER, that copies of this resolution be furnished all agencies concern for their information and guidance. **ADOPTED UNANIMOUSLY**.....


