FAVORABLY ENDORSING THE AMENDMENT OF THE DEVELOPMENT PERMIT OF ISLAND FRONT RESIDENCES, A SUBDIVISION DEVELOPMENT PROJECT BEING DEVELOPED BY JASA BUILDERS AND DEVELOPMENT CORPORATION, ENDORSED UNDER RESOLUTION NO. 2014-27, DATED MARCH 10, 2014 TO INCLUDE THE EXPANSION AREA RECENTLY RECLASSIFIED UNDER ORDINANCE NO. 2014-18, DATED SEPTEMEBR 16, 2014 CONTAINING AN AREA OF TWENTY FOUR THOUSAND NINE HUNDRED FIFTY SIX (24,956) SQUARE METERS SITUATED AT BRGY. LUCAP AND BRGY. MAGSAYSAY, THIS CITY

WHEREAS, Resolution No. 2014-27, adopted by this body favorably endorsed the issuance of Development Permit to Island Front Residences, a subdivision project, being developed by JASA Builders and Development Corporation ;

WHEREAS, this august body duly enacted City Ordinance No. 2014-18, dated September 16, 2014, reclassifying additional four parcels of land owned by **JASA BUILDERS AND DEVELOPMENT CORPORATION**, containing an area of twenty four thousand nine hundred fifty six square meters (24,956) situated at Brgy. Lucap and Brgy. Magsaysay from agricultural to residential use;

WHEREAS, the proponent corporation duly informed the body that they intend to utilized the area recently reclassified for the proposed expansion of the subdivision project;
