RESOLUTION NO. 2014-117

RESOLUTION AUTHORIZING THE CONVERSION (REHABILITATION AND RECONSTRUCTION) OF THE DON LEOPOLDO SISON AUDITORIUM, THIS CITY

WHEREAS, this august body duly adopted Resolution No. 2014-28, authorizing the Honorable City Mayor, Arthur F. Celeste, to negotiate and enter into a loan agreement with the Land Bank of the Philippines in the amount of One Hundred Seventy-Five Million Pesos (Php 175,000,000.00);

WHEREAS, the loan was intended to implement projects aimed to boost local tourism and develop the Hundred Islands National Park to be a world class tourist destination;

WHEREAS, one of the identified projects envisioned to be implemented and to be funded by the loan is the conversion (Rehabilitation and Reconstruction) of the Don Leopoldo Sison Auditorium situated at the central business district with an estimated area of one thousand nine hundred (1,900) square meters into a convention center which may be utilized for conferences, symposia and other public gatherings or meetings;

NOW THEREFORE, upon due deliberation of the merits surrounding the issue and on motion of Councilor Fatima Ann Sison-Isla, co-sponsored by Councilor Joseph T. Bacay and duly seconded by Councilor Margielou Orange D. Humilde, it was

RESOLVED as it is hereby **RESOLVED** to authorize the conversion (rehabilitation and reconstruction) of the Don Leopoldo Sison Auditorium located along Quezon Avenue, this city.


