“RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR ARTHUR F. CELESTE, TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) BY AND IN-BETWEEN THE CITY OF ALAMINOS AND THE DEPARTMENT OF AGRICULTURE-REGIONAL FIELD OFFICE I, REPRESENTED BY EXECUTIVE REGIONAL DIRECTOR, DR. VALENTINO C. PERDIDO, AND THE AGRICULTURE AND FISHERY COUNCIL CHAIRMAN, MR. VINCENT A. ADORNA, FOR THE PROVISION OF FARM EQUIPMENTS FOR CORN PRODUCTION TO FARMERS/FARMERS’ ORGANIZATION IN THE CITY OF ALAMINOS”

WHEREAS, the Department of Agriculture (DA) thru its Regional Field Unit I (RFU I) is implementing the Agri-Pinoy Maisan Program with primary goals of ensuring national corn sufficiency and enable farmers to increase farm income;

WHEREAS, one component of the Program is the provision of farm equipment under cost sharing arrangement of 85% - 15% with the recipients;

WHEREAS, in support to the Program, a total area of six (6) hectares of corn plantation in the City of Alaminos was established in partnership with DA and farmer cooperators;

WHEREAS, the City of Alaminos continues to provide technical services to farmers through its Corn Production Program;

WHEREAS, cognizant of the Agriculture and Fishery Council’s (AFC) potential as partner in development that would provide private sector views and inputs, the Secretary of Department of Agriculture (DA) issued Special Order No. 542, Series of 2007 authorizing the AFC to monitor and validate DA programs and projects;

NOW THEREFORE, after due deliberation on the merits surrounding the issue and on motion of Councilor Rufina J. Gabriel, co-sponsored by Councilor Perlito V. Rabago, duly seconded by Councilor Fatima Ann S. Isla, it was
