**WHEREAS**, Alaminos City is now gaining world attention in its tourism related programs aside from being the commercial, educational and trade center in Western Pangasinan;

**WHEREAS**, being the center of trade and industry in Western Pangasinan and a tourist destination, there is an steady influx of people from various places causing some concern in the maintenance of peace and order in the locality;

**WHEREAS**, the local police force in the City of Alaminos consist of fifty eight (58) personnel which is far way behind the international ideal ratio of one policeman per 500 population, causing a major setback in the prevention of crimes as well as in the implementation of the peace and order program in the city;

**NOW THEREFORE**, upon due deliberation of the merits surrounding the request and on motion of Councilor Perlito V. Rabago, co-sponsored by Councilor Jose Antonio Miguel Y. Perez, duly seconded by Liga ng mga Barangay President, Salvador C. Camba, it was

Roxas III, Secretary, Department of Interior and Local Government, thru Director General Alan La Madrid Purisima, PNP Chief, for additional thirty (30) policemen to augment the number of local police force in the City of Alaminos, Pangasinan;

**RESOLVED FURTHER**, that this resolution be forwarded to the Office of the Honorable Secretary Manuel A. Roxas III thru the Office of PNP Chief Alan LM. Purisima for information and appropriate action.

**RESOLVED FINALLY** that copies of this resolution be furnished to the Office of Police Chief Superintendent Roman Alano Felix, Regional Director, PNP, Region I and Senior Police Superintendent Reynaldo Guban Biay, Provincial Director, PNP, Province of Pangasinan for information and guidance.


