RESOLUTION REQUESTING THE HONORABLE SECRETARY, LEILA DE LIMA, DEPARTMENT OF JUSTICE, TO CAUSE THE ESTABLISHMENT/SETTING-UP OF A SATELLITE NBI OFFICE IN THE CITY OF ALAMINOS, PANGASINAN

WHEREAS, the first District of Pangasinan, comprising eight (8) municipalities and the City of Alaminos, is located in the western part of Pangasinan;

WHEREAS, the City of Alaminos is the center of commerce and tourism in the District;

WHEREAS, being the hub of economic activity, the presence of a Satellite Office of the National Bureau on Investigation would be of great significance not only in the maintenance of peace and order but primarily on the issuance of NBI clearance which is a primary requirement for local as well as foreign employment;

WHEREAS, for employment purposes, constituents of the mentioned municipalities including this city have to apply and secure their NBI Clearances at the NBI District Office at Dagupan City, Pangasinan, thus causing inconvenience, loss of time and resources on our constituents;

WHEREAS, there is a need to install/set-up a satellite NBI office in the City of Alaminos to reach the general public and for the NBI to render convenient and effective service in conformity with its bounden duty as embodied in R.A. 157, the law creating the Bureau;

WHEREFORE, premises considered and on motion of Councilor Jose Antonio Miguel Y. Perez, co-sponsored by Councilor Jan Marianne R. Fontelera, duly seconded by Councilor Fatima Ann S. Isla, Councilor Perlito V. Rabago and Liga ng mga Barangay President Salvador C. Camba, it was




