RESOLUTION NO. 2014-62

RESOLUTION REQUESTING THE HONORABLE CITY MAYOR ARTHUR F. CELESTE, TO PROVIDE THE SANGGUNIANG PANLUNGSOD A SPACE FOR THE POSTING/PUBLICATION OF ITS NOTICES, ANNOUNCEMENTS AND OTHER LEGISLATIVE ACTS AT PLAZA ENRIQUE BRAGANZA.

WHEREAS, enshrined in our constitution is the policy that the state recognizes the vital role of communication and information in nation building;

WHEREAS, pursuant to Book VII, Chapter 2, Section 9, of the Revised Administrative Code, it provides that, an agency shall, as far as practicable, publish or circulate notices of proposed rules and afford interested parties the opportunity to submit their views prior to the adoption of any rule.

WHEREAS, the clear object of the above quoted provision is to give the general public adequate notice of the various laws which are to regulate their actions and conduct as citizens. Without such notices and publication there would be no basis for the applications of the maxim "Ignorantia Legis non excusar". It would be the height of injustice to punish or otherwise burden a citizen for the transgression of a law which he had no notice whatsoever. Equally important is the provision embodied in our constitution which states that "No person shall be deprived of life, liberty and property without due process of law".

WHEREAS, to give effect to the aforesaid provisions, a space for the posting/publication by the Sanggunian of its notices, announcements and the like shall be provided at Plaza Enrique Braganza, which shall be open, exclusive, visible to the public and available at all times for use by the Sanggunian for the above mentioned purpose and with a minimum length of four (4) feet and minimum width of six (6) feet.

NOW THEREFORE, on motion of Councilor Jose Antonio Miguel Y. Perez, duly seconded by Councilor Jan Marionne R. Fontelera and Councilor Perlito V. Rabago, it was

RESOLVED as it is hereby **RESOLVED** to request the honorable City Mayor Arthur F. Celeste, to provide the Sangguniang Panlungsod a space for the posting/publication of its notices, announcements and other legislative acts at plaza Enrique Braganza.

RESOLVED FURTHER that copy of this resolution be forwarded to the office of the Honorable City Mayor for information and appropriate action. **ADOPTED UNANIMOUSLY**.....
