**"RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE ARTHUR F. CELESTE, TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) BY AND IN-BETWEEN THE CITY OF ALAMINOS, PANGASINAN AND THE DEPARTMENT OF LABOR AND EMPLOYMENT REGIONAL FIELD OFFICE 1 (DOLE-RO1) FOR THE IMPLEMENTATION OF THE EMERGENCY EMPLOYMENT PROGRAM, "TULONG PANGHANAPBUHAY SA ATING DISPLACED/DISADVANTAGED WORKERS (TUPAD) AND ALLOCATING TWENTY PERCENT (20%) OF THE TOTAL PROJECT COST AS THE LGU EQUITY"**

**WHEREAS**, the Department of Labor and Employment, Regional Office I is tasked to coordinate and implement emergency employment program under TUPAD Program which aims to enable the displaced workers, the underemployed and unemployed poor to engage in short-term community works providing temporary wage employment;

**WHEREAS**, the Department of Labor and Employment has allocated project funds for the implementation of this program in partnership with the concern Local Government Units;

**WHEREAS**, the "LGU-Alaminos City" signified its intention to be one of the recipients of this project and the intention is duly supported by endorsement made by the authorized local officials;

**WHEREAS**, as an equity, twenty percent (20%) of the total project cost will be allocated for the provision of tools and jigs, and for supervision and monitoring of the proposed project;
