CELESTE, TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) BY AND IN-BETWEEN THE CITY OF ALAMINOS AND THE DEPARTMENT OF AGRICULTURE-REGIONAL FIELD OFFICE I, REPRESENTED BY EXECUTIVE DIRECTOR VALENTINO C. PERDIDO, Ph.D., AND THE AGRICULTURE AND FISHERY COUNCIL, REPRESENTED BY REGIONAL AGRICULTURAL AND FISHERY COUNCIL CHAIRMAN, MR. VINCENT A. ADORNA FOR THE PROPOSED CONSTRUCTION OF SMALL IRRIGATION PROJECT IN THE CITY OF ALAMINOS, PANGASINAN"**

**WHEREAS**, the Department of Agriculture (DA) pursuant to its mandated function of promoting agricultural development through a bottom-up self reliant farm systems approach that will emphasize social justice, equity, productivity and sustainability in the use of agricultural resources is providing integrated services to ensure the increase in farm productivity as well as real-income of small farmers;

**WHEREAS**, the Local Government Code of 1991 allows the national agency to complement national funded requests facilities, programs and services jointly or with the assistance of the Local Government Units;

**WHEREAS**, the Local Government Units (LGUs) identified the sites and requested the release of fund for the construction and/or rehabilitation/improvement of small irrigation project in the priority areas;

**WHEREAS**, cognizant of the AFC's potential as partners in development that would provide private sector views and inputs, the Department of Agriculture (DA) Secretary issued Special Order No. 542, Series of 2007 authorizing the "AFC" to monitor and validate DA programs and projects;

**WHEREAS**, the "DA-RFO I"; "LGU-Alaminos City" and "AFC" agreed to cooperate and jointly implement the above-cited project thru its Memorandum of Agreement;

**NOW THEREFORE**, after due deliberation on the merits surrounding the issue and on motion of Councilor Rufina J. Gabriel duly seconded by Councilor Joseph T. Bacay and Councilor Perlito V. Rabago, it was
