CELESTE TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE PANGASINAN STATE UNIVERSITY - ALAMINOS CITY CAMPUS, FOR THE ESTABLISHMENT OF A SYSTEMATIC PROCEDURE IN THE LGU - SCHOLARSHIP PROGRAM FOR GRANTEES ENROLLED AT THE PANGASINAN STATE UNIVERSITY

WHEREAS, the Pangasinan State University - Alaminos City Campus, Alaminos City, Pangasinan is tasked with the mission to produce responsible, productive and morally upright students dedicated to the pursuit of countryside development;

WHEREAS, the LGU-Alaminos City is continuously implementing the Alaminos City Scholarship Program (ACSP), which aims to provide support to poor but deserving students to attain higher education;
