RESOLUTION AUTHORIZING THE TRANSFER OF THE PROJECT, " RENOVATION/UPGRADING OF PLAZA MARCELO OCHAVE AND CHILDREN'S PARK", AMOUNTING TO ELEVEN MILLION THREE HUNDRED THOUSAND PESOS (PHP 11,300,000.00) TO THE NEWLY ESTABLISHED ALAMINOS CITY CHILDREN'S PARK AND ACTIVITY CENTER AT SABARO STREET, POBLACION, ALAMINOS CITY

WHEREAS, the "Renovation/Upgrading of Plaza Marcelo Ochave and Children's Park" with an allocated fund of amount of Eleven Million Three Hundred Thousand Pesos (Php 11,300,000.00) was one of the duly approved projects under City Development Council Resolution No. 03, series of 2012;

WHEREAS, the said project entailed the construction of rope courses, zip lines and integrated play equipment for children;

WHEREAS, upon assumption of the present administration, the implementation of the said project was temporarily suspended, pending review of the viability of the said project;

WHEREAS, Ordinance No. 2014-08 dated June 03, 2014, the Sangguniang Panlungsod established a Alaminos City Children's Park and Activity Center at the former location of the City Motor pool at Sabaro Street, Poblacion, Alaminos City;

WHEREAS, in view of space considerations, safety of the intended beneficiaries of the Plaza Marcelo Ochave project, and considering further that the original site is located in the heart of the central business district of the City, the Office of the Mayor requested that the said project be transferred to the newly created Alaminos City Children's Park and Activity Center in Sabaro Street, Poblacion, Alaminos City;

WHEREFORE, premises considered upon meticulous study, and on motion of Councilor Fatima Ann S. Isla, duly seconded by Councilor Rufina J. Gabriel and Liga ng mga Barangay President Salvador C. Camba, it was
