RESOLUTION STRONGLY ENDORSING BARANGAY RESOLUTION NO. 22, SERIES OF 2014 OF THE SANGGUNIANG BARANGAY OF AMANDIEGO, ALAMINOS CITY, PANGASINAN, REQUESTING THE HONORABLE DILG SECRETARY MANUEL A. ROXAS II, TO ALLOCATE THE AMOUNT OF THREE MILLION PESOS (PHP 3,000,000.00) FROM HIS DISCRETIONARY FUNDS FOR THE CONSTRUCTION OF A MULTI-PURPOSE COVERED AUDITORIUM AT BARANGAY AMANDIEGO, THIS CITY.

WHEREAS, the Sangguniang Barangay of Brgy. Amandiego, Alaminos City, Pangasinan furnished this august body, Brgy. Resolution No. 22, series of 2014 adopted on June 8, 2014, entitled "*Resolution requesting funding from the Department of Interior and Local Government (DILG) for the construction of a multi-purpose covered auditorium amounting to Three Million Pesos (Php 3,000,000.00) through Hon. Secretary Manuel A. Roxas II*" for consideration and further endorsement of this body;


