DECLARING BARANGAY ORDINANCE NO. 01 SERIES OF 2014, OF BARANGAY QUIBUAR ENTITLED: "ADOPTING CITY ORDINANCE 2003-22, ENTITLED, AN ORDINANCE PRESCRIBING CURFEW HOURS FOR MINORS, PROVIDING PENALTIES FOR VIOLATING THEREOF AND FOR OTHER PURPOSES", ENACTED WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BARANGAY.

WHEREAS, the Barangay Council of Quibuar submitted for review and evaluation its Barangay Ordinance Nos. 01 and 02, both series of 2014, pursuant to Item paragraph (a) (i) ART. 99, RULE XVII, of the Rules and Regulations Implementing Republic Act 7160 otherwise known as the Local Government Code of 1991;

WHEREAS, the Laws and Rules Committee of this august body conducted initial review and evaluation on the documents submitted and found out that the same is in order and enacted within the conferred powers of the Barangay Council, pursuant to paragraph (a) Items (1) ART. 101 of the same Act;

WHEREAS, after the subsequent thorough review and evaluation on the subject barangay ordinance, this body during its regular session finally found the foregoing ordinance to be in order;

NOW THEREFORE, on motion of Councilor Fatima Ann S. Isla, duly seconded by Councilor Rufina J. Gabriel, it was

RESOLVED to declare as it is hereby **DECLARED** that Barangay Ordinance No. 01 series of 2014, of Barangay Quibuar entitled: "Adopting City Ordinance 2003-22, entitled, An Ordinance prescribing curfew hours for minors, providing penalties for violating thereof and for other purposes" enacted within the conferred powers of the Sangguniang Barangay.
