RESOLUTION AUTHORIZING HONORABLE CITY MAYOR, ARTHUR F. CELESTE TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE HUNDRED ISLANDS GAWAD KALINGA ECO-VILLE KAPIT-BAHAYAN ASSOCIATION, REPRESENTED BY ITS PRESIDENT, MR. RICHARD BALZA, ON THE UTILIZATION OF THE LGU-OWNED PROPERTY AT BARANGAY LUCAP, FOR RICE PRODUCTION

WHEREAS, the LGU-Alaminos City aims to attain sustainable development through empowerment of the people by continuously implementing programs for employment generation and alternative livelihood;

WHEREAS, the Hundred Islands Gawad Kalinga Eco-Ville Kapit-Bahayan Association is the association of the recipients of the housing project of the LGU-Alaminos City in partnership with the Gawad Kalinga Community Development Foundation, Inc. at Brgy. Lucap this city;

WHEREAS, the LGU-Alaminos City owns a parcel of Agricultural land containing an area of Twenty Nine Thousand One Hundred Forty Two (29,142) square meters, situated at Barangay Lucap, this city and declared under Tax declaration No. 2761 which is not yet being utilized for any productive purpose;

WHEREAS, the ASSOCIATION, is now requesting to conduct farming activities on the said LGU property as an alternative livelihood activity and is willing to comply with the conditions set forth by the City Government pertaining to the utilization of the area;

NOW THEREFORE, upon due deliberation on the merits surrounding the issue and on motion of Councilor Rufina J. Gabriel, duly seconded by Fatima Ann S. Isla, it was

RESOLVED as it is hereby **RESOLVED**, to authorize the Honorable City Mayor Arthur F. Celeste to enter into Memorandum of Agreement with the Hundred Islands Gawad Kalinga Eco-Ville Kapit-Bahayan Association represented by its President, Richard Balza, for the utilization of the LGU owned property at Brgy. Lucap for rice production as an alternative livelihood activity of the Association;
