RESOLUTION AUTHORIZING HONORABLE CITY MAYOR, ARTHUR F. CELESTE, TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) BY AND IN-BETWEEN THE CITY OF ALAMINOS, PANGASINAN, THE AGRICULTURE AND FISHERY COUNCIL (AFC), REPRESENTED BY REGIONAL AGRICULTURAL AND FISHERY COUNCIL (RAFC) CHAIRMAN, MR. VINCENT A. ADORNA AND THE DEPARTMENT OF AGRICULTURE REGIONAL FIELD OFFICE I (DA-RFO I) REPRESENTED BY REGIONAL EXECUTIVE DIRECTOR, VALENTINO C. PERDIDO, PH.D., FOR THE IMPLEMENTATION OF CY 2014 GRASSROOTS PARTICIPATORY BUDGETING PROJECTS FOR AGRICULTURAL PROJECTS (HVCDP AND ORGANIC FARMING)

WHEREAS, THE Department of Agriculture (DA) promotes agricultural development through a bottom-up self-reliant farm systems approach that will emphasize social justice, equity, productivity, and sustainability in the use of agricultural resources;

WHEREAS, cognizant of the AFC's potential as partners in development that would provide private sector views and inputs, the Secretary of the Department of Agriculture (DA) issued Special Order No. 542, Series of 2007 authorizing the Agriculture and Fishery Council to monitor and validate DA programs and projects;

WHEREAS, the Department of Budget and Management (DBM) issued to the Department of Agriculture, funds under the General Appropriations Act FY 2014 which will be made available for expenditure in relation to the implementation of CY 2014 Grassroots Participatory Budgeting Projects for various agricultural projects;

WHEREAS, the Local Government Code of 1991 allows the national agency to complement national funded projects, facilities, programs, and services jointly or with the assistance of the Local Government Units (LGUs);

WHEREAS, the LGU-Alaminos City's thrust on agriculture is the implementation of HVCDP and ORGANIC FARMING in the locality as a vital project for agricultural development and production;

WHEREAS, the City Government of Alaminos City, Pangasinan and the "DA RFO-I" agreed to cooperate and jointly implement the above cited project;






