### RESOLUTION NO. 2014-98

**RESOLUTION DECLARING/AUTHORIZING THE USE OF THE ACQUIRED PROPERTIES OF THE CITY GOVERNMENT OF ALAMINOS, PANGASINAN IDENTIFIED AS LOT NO. 1, PLAN PSU-35252 COVERED BY TCT NO. 32722 CONTAINING AN AREA OF 9,823 SQUARE METERS; AND LOT NO. 1-B PSU-81329 COVERED BY TCT NO. 32723 CONTAINING AN AREA OF 29,142 SQUARE METERS AS THE RESETTLEMENT/RELOCATION SITE FOR INFORMAL SETTLERS.**

**WHEREAS**, it is declared policy of the National Government to provide the people with adequate and decent housing facilities and to encourage various stakeholders to participate in the housing program of the government;

**WHEREAS**, Executive Order No. 90 dated December 17, 1986 mandated the National Housing Authority (NHA) as the sole production agency to meet the housing needs of the low and marginal families in the urban and urbanizing areas;

**WHEREAS**, pursuant to Republic act no. 7160, better known as the Local Government Code of 1991, and the Urban Development and Housing Act of 1992 (RA 7279), Local Government Units are mandated to take principal role in the provision of housing services to its constituents;

**WHEREAS**, in view of the devastation brought by the calamities leaving thousands of damaged houses, NHA included in its Work Program and Budget for CY 2012 the development of resettlement project to accommodate informal settler families affected by calamities and those living in danger areas;

**WHEREAS**, the Honorable City Mayor Arthur F. Celeste, thru a letter dated August 22, 2013 requested the assistance of the National Housing Authority in the development of the identified resettlement area for informal settlers along Barangay Lucap, Alaminos City, Pangasinan;

**WHEREAS**, the NHA Board of Directors approved the work Program and Corporate Operating Budget of the NHA for the FY 2012, which includes among others, the land development of a resettlement project for the City of Alaminos, Pangasinan with a budget allocation of Php 12 Million under its Regional Resettlement Assistance Program;
