RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR, ARTHUR F. CELESTE TO CAUSE THE ESTABLISHMENT OF A CITY BIRTHING FACILITY AT BRGY. BOLANEY, ALAMINOS CITY, PANGASINAN

WHEREAS, it is a declared policy that the State shall protect the life of the mother and the life of the unborn from conception ;

WHEREAS, the Department of Health issued Administrative Order 2008-0029 to implement Health reforms for rapid Reduction of Maternal and Neonatal Mortality and the Strategy towards improvements of intermediate health outcomes, one of which is the facility-based delivery;

WHEREAS, the establishment of birthing facility is to address the pressing need of pregnant women to deliver at an accredited and licensed birthing institution by discouraging delivery of birth at home; to minimize infant neonatal death; and to maintain Zero Maternal Mortality in the city;

WHEREAS, the Sangguniang Panlalawigan enacted Provincial Ordinance No. 164-2012 entitled, "An ordinance establishing and adopting set of measures and systems supporting maternal, neonatal and child health and nutrition strategy of the Department of Health", as a tool to reduce if not totally eradicate maternal and infant deaths in the province;

WHEREAS, the city government of Alaminos City in support to Provincial Ordinance No. 164-2012 and to reduce if not eradicate maternal, neonatal death in the city, intends to establish a birthing facility at the building owned by the LGU-Alaminos City, at Brgy. Bolaney, this city;

NOW THEREFORE, upon due consideration of the merits of the proposal and on motion of Councilor Jan Marianne R. Fontelera, co-sponsored by Councilor Rufina J. Gabriel, duly seconded by Councilor Fatima Ann S. Isla, it was
